
Kemble Community Gardens is leased by Kemble & Ewen Parish Council from the CDC. The site is managed by a committee and I am the secretary for that committee.

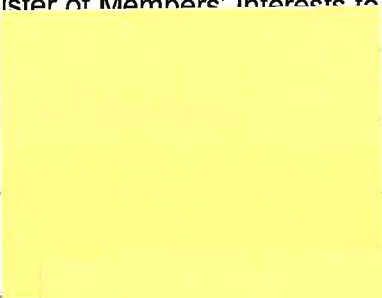
